Welcome to OctoberTour 2018! OctoberTour is Historic Salisbury Foundation's largest fundraiser of the year and one of Salisbury's most prominent events. The following information will help prepare you for your participation in the 2018 Bank Street Bistro and Brews. Please read carefully and keep these first two pages for reference. The last page is a form to fill out and return, either by email, mail or in person at the HSF office at the Salisbury Depot, in order to register and assign you a location that suits your needs. We look forward to another successful year with your participation!

- **There is a fee from Historic Salisbury Foundation to participate. Vendors requiring electricity are asked to contribute \$50 and vendors not requiring electric are asked to contribute \$25. Please include this payment with your registration forms, or take it directly to HSF at the depot with 'Bank Street Bistro and Brews' on the Memo line.**
- Tour Dates and Times: October 13th (10am-5:30pm) and 14th (12-5:30pm). See section below regarding a wine wrap-up and reception Sat. evening.
- Set up begins at 8am Sat. morning on South Rowan Avenue between 3<sup>rd</sup> and 4<sup>th</sup> Streets, adjacent to Library Park. We assign/coordinate your location on the street based on the varying needs, electrical and otherwise, of participants. Vendors have until 9:30 am to complete set up. You will be provided with an assigned spot prior to Saturday morning.
- South Rowan Avenue will close to anything but foot traffic and vendor setup at 8pm Friday. During the tour hours, you may drive up to a street nearby for delivery of food, ice, etc. to your booth, but vehicle traffic will be prohibited beginning around 9:30am Sat.
- There will be tables for guests, and live entertainment will be provided.
- Security will be provided overnight on Saturday from 7pm to 7am.
- Set-up reopens 9am Sunday morning.
- You may need a Temporary Food Vendor Permit from Rowan Co. Health Dept (\$50), and it is up to you to call them to make sure you meet all of their requirements. - **NEW THIS YEAR** – The Town of Spencer requires a \$5 peddler's license and a

copy of your driver's license. The peddler's license can be obtained through the Town Clerk by calling 704-633-2231.

- We can have electrical hook ups for you if needed, but they are limited, and we will need to know 2 weeks ahead of time in order to assign you a location that suits your needs. Please indicate on your registration if you will need electricity.
- Please restrict your area to only what you really need.
- You can vend starting and ending at whatever times you wish, and set your own prices, but please help us and fellow vendors by giving us your very best estimation on times and offerings.
- Alcohol will again be among the offerings this year and will be sold in one location at Library Park Saturday afternoon, evening, and Sunday afternoon. Consumption is allowed only in the confines of the Library Park property and the closed portion of South Rowan Avenue. If you have any questions or concerns regarding this, please see contact information below.
- The 'after hours' reception will continue again this year, for the talented Plein-Air artists that will be painting homes during the tour. The event will continue until **7pm**. The general public will stay for the OctoberTour After Hours and are welcome to engage artists during the reception. You are welcome to stay the entire time or leave early, but please do your best to accurately assess your intentions.

For all participants - civic organizations and food vendors - we encourage you to promote your business/organization's mission statement and messages consistent with that goal, but please refrain from being pushy or leaving your booth space to do so.
